

Guidelines for Earthan Governance:

We are Sovereign Earthans, the citizens of this planet; it is *we* who are free, individually and collectively. Our governance will exist and function by our mandate solely to achieve the objectives we establish for it. We own ourselves individually, and we own our governance and everything that enables it – our governance owns no one and no thing, not itself and not us.

- Our governance has no rights, it is we who have rights, it is we who empower it.
- Our governance has no powers beyond those that we assign to it, and those only in explicit and limited measure as we determine and articulate.
- Our governance is not empowered to dictate to us it is we who mandate to it.
- Our governance is not empowered to repress us it is we who it serves, and it is we who hold its reigns.
- Our governance is not authorized to undertake activities that we have not explicitly directed Our governance works for us, by direction, on our behalf.
- Our governance will refrain and desist from all attempts to supersede our authority with its own; it will make accurate, truthful, and complete accountings of all its actions.
- Our governance will serve our purposes, address our requirements, and achieve the
 objectives that we establish for it.
- Our governance will not take our property, there will be no right of eminent domain.
- Our governance will not assault our individual or collective liberties, freedoms, or lives.
- Our governance will not make commitments that we have not explicitly authorized.
- Our governance will not establish nor maintain empires, nor standing militaries beyond those forces deemed by us to be legitimately necessary to ensure our collective security against genuine existential threats.
- Our governance will not tax us in excess beyond what we determine to be a reasonable percentage and that we authorize for standardization. Nor will it spend our wealth on items or actions that we have not explicitly endorsed. Our governance will not overspend us beyond our means, nor draw us into debt. Taxation shall be proportional to income for individuals, and all commercial, private, or special interest enterprises.

- Our governance will not delegate the management of our economy.
- Our governance will maintain a non-inflatable monetary standard and medium of exchange linked directly to a valuable physical commodity (i.e. gold & silver) using a standard rate of exchange that it will not be allowed to inflate or manipulate.
- Our governance will not attempt to restrict our free and fair exchange, nor will it attempt to mandate the medium of exchange that we may employ.
- Our governance will not interfere in the normal conduct of our business, or in the normal management of our personal daily affairs beyond enforcing an agreed upon rule-of-law that we determine and explicitly authorize governance to monitor & maintain.
- Our governance will not employ force, coercion, or violence against us except as we
 authorize on specified bases to uphold our common agreed upon rule-of-law, and to
 protect our persons and property rights.
- Our governance will not attempt to restrict or monitor the travels, associations, or private affairs of citizens in good standing.
- Our governance will not attempt to limit our freedom to speak publicly, nor attempt to censor the content of our speech; nor attempt to restrict our access to information about its own activities, nor attempt to restrict our expression of dominion over it.
- Our governance will stay out of our individual business, stay out of our private lives, and stay out of our homes except as we explicitly authorize.
- Our governance will remember at all times that it is in our employ at our pleasure; and any privilege, authority, or remuneration it may be allotted by virtue of its duties and performance can be adjusted by us at any time. We, as beneficiaries of honest and competent governance will be generous and just, and ensure that those individuals engaged in good governance are adequately compensated and publicly honored.

This is how it must and will be for Earthan communities. Our governance is our creation; and it is we who allow or deny, empower or restrict its form and its actions...never the opposite.
